

1. Welcome, Call to Order and Declaration of Quorum

Quorum is 17 Organizational Members (25% of 68). We have 11 members present, and have received e-mailed ballots and proxies for 12 additional Organization Members bringing the total to 23.

5.1 Approval of Audited Financial Statements

Chair asks for a motion to approve the Audited Financial Statements for 2014-2015. Moved by Jennifer Ellis, Gateway Learning and seconded by Jo Cryderman, Literacy Society of South Muskoka.

5.2 Motion for Appointment of Auditor for 2015-2016

Chair asks for a motion to appoint Curtis Villar as LLO's auditors for 2015-2016.

Moved by Marie Belliveau, Niagara Regional Native Centre and seconded by Judy DesRoches, Barrie Literacy Council.

No Discussion. Motion carried.

6.0 Proposed Bylaw Amendments

Jo Cryderman presented the proposed amendments to the bylaws.

2.1 Mission Statement

Currently reads – Laubach Literacy Ontario supports its member agencies in the achievement of higher levels of literacy throughout the province.

Recommended Amendment:

2.1 Laubach Literacy Ontario provides training, resources and services to meet the changing needs of our members and adult students to create a stronger, more literate Ontario.

Chair asks for a motion to accept the proposed bylaw amendment.

Moved by Helen McLeod, Hamilton Literacy Council and seconded by Pedobnoque Shawbedees. Saugeen Enjikendaaswiing Zhaang.

No Discussion. Motion carried.

4.1 Number of Directors and Qualification

Currently reads – The affairs of the Corporation shall be managed by a board of nine (9) directors, each of whom at the time of election or within 10 days thereafter and throughout the term of office shall be a member of the Corporation.

Recommended Amendment:

4.1 Number of Directors and Qualification:

The affairs of the Corporation shall be managed by a board of (6) directors, each of whom at the time of election or within 10 days thereafter and throughout the term of office shall be a member of the Corporation.

Rationale: Due to no project funding, and no Core funding increase, the Board and staff looked at ways to reduce overhead. We are recommending a smaller board, and fewer face-to-face meetings. As well, LLO's Board of Directors is now a governance board. One of the six directors will be a student representative elected at the Annual Student General Meeting.

Discussion: Helen McLeod, Hamilton Literacy Council suggested there should be a Trainer on the board at all times. We currently have one but maybe we need to change the bylaws to indicate this.

Helen also questioned the even number of board members. It was explained that the Chair does not have the right to vote except when there is a tie vote, in which case the chair shall break the tie by voting according to his or her own judgement of the issue.

Chair asked for a motion to accept. Moved by Helen McLeod, Hamilton Literacy and seconded by Michelle Davis, Ontario Native Literacy Coalition.

No further discussion. Motion carried.

7. Nominations Report

Alicea Fleming, Chair of the Nominations Committee summarized the nominations report.

Chair asks for a motion to accept the slate. Moved by Pedobnoque Shawbedees, Saugeen Enjikendaaswiing Zhaang.

Treasurer's Report



The Statement of Revenues and Expenditures reveals that LLO ended the 2016 year with a fund balance of 101,839 in our General Fund (unrestricted).

We show a \$25,251.00 deficit of revenue over expenses this year. This means that we had to dip into our accumulated surplus by that amount of money.

Our General Fund—accumulated over the years—include donations, membership fees, investment interest, and other sources of revenue apart from the Ministry of Training, Colleges and Universities core funding—particularly our Social Enterprise, the Laubach Literacy Bookstore.

Profits from the bookstore of \$9,971.00 were used to reduce conference registration fees for students, and to help subsidize travel for member agencies to attend the conference. Our book sales for this year were up (\$48,884) thanks to a large order from New Brunswick Public Library. Unfortunately the exchange was working against us and we had to increase our prices by a small amount, although member agencies still enjoy a 30% discount on purchases.

Donations for this year totaled \$784.00, about half of what we received last year. Donations were received from PricewaterhouseCoopers Canada Foundation in recognition of Henry Sum, a previous board member. One of our board members, who prefers to remain anonymous, donates monthly through Canada Helps. Murray Bechtel also made a generous donation towards the student conference registrations. Once again, we received a donation from CUPE Local 1512, towards supporting literacy students to attend the conference. Various other donations were also received.

Except for the bookstore, revenue was down significantly due to not having any projects, while in most cases-- except for board meeting costs--expenditures have increased. Board meeting costs were reduced by over 50% due to reducing the number of board members and the number of face-to-face meetings.

We would like to thank MTCU for the core funding received to support our business plan, and the additional funding for two in-year projects.

INDEPENDENT AUDITOR'S REPORT

To the Members of Laubach Literacy Ontario

We have audited the accompanying financial statements of Laubach Literacy Ontario, which comprise the statement of financial position as at March 31, 2016 and the statements of revenues and expenditures, changes in net assets and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements present fairly, in all material respects, the financial position of Laubach Literacy Ontario as at March 31, 2016 and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Nominations Committee

The Nominations Committee this year was comprised of two LLO Board members: Alicea Fleming, Chair of the Nominations Committee and Mary Ann Fuduric, Treasurer; and Lana Faessler, Executive Director of Laubach Literacy Ontario.

Nominations Policies and Procedures

LLO reviews the skills of the board of directors annually. Based on identified gaps in skills, the Nominations Committee recruits individuals for election to the LLO Board of Directors.

Nomination forms for the board of directors and the student representative were sent to each member organization via email. Nominations were closed on May 17, 2016 (30 days prior to the AGM as per our bylaw).

Nominations Procedures

In accordance with policy guidelines, all students attending the Student Annual Meeting at each year's conference have the right to elect a student representative. As there was only one nomination received, an election for student representative will not be needed. The student representative is Rubert Payea, who served as LLO's student representative from June 2011-June 2012.

Once elected, the provincial Student Representative will be bound by all the governing regulations that apply to the LLO Board of Directors as set out in the LLO bylaw.

As there were no board nominations received, and there are five existing board members who are standing for the five vacant positions on the Board, an election will not be needed.

Highlights of 2015-2016

Successful completion of 16 core Business Plan deliverables, funded by MTCU, which included:

- ♣ Another successful annual conference, with 24 workshops and events. Over 125 attendees including LBS staff, volunteers, EO staff, support org. staff, presenters and learners. Proceeds from our social enterprise, Laubach Literacy Bookstore, provided travel subsidies to member agencies, and reduced fees for literacy students. - ♣ Two blended trainer workshops for apprentice tutor-trainers.
- ♣ Maintenance of LETS (Laubach Enhanced Training System), the Trainingpost Moodle platform, and our interactive website.
- ♣ A webinar, in partnership with Literacy Link South Central, on Working Effectively with Lower-Level Learners
- LBS Best Practices in the West". Results were shared with member agencies across Ontario.
- ♣ Supporting and informing members through increased communications, needs surveys, bi-monthly LLO Express, and bi-annual Expressions e-magazine.

Projects:

Two in-year short-term projects (six weeks) were completed by March 31st, 2016:

♣ Investigate potential for cost-shared, province-wide public service announcements (PSAs) to attract potential learners. Invite support organizations to participate in the creation of a province-wide campaign plan, including feasibility of cost-sharing/resource-sharing, or submitting a project proposal to ministry, Trillium or other source. Leaste an intro to ESL-literacy tutoring online Moodle module. Repurpose excellent ProLiteracy ESL training materials for clients that meet the LBS eligibility criteria (benchmark 6) but have additional barriers/needs.

LLO's SOCIAL ENTERPRISE



Laubach Literacy Ontario is a proud distributor of New Readers Press materials, including a variety of resources for tutors, trainers, teachers and adult literacy students.

We also offer free downloads of many publications and resources researched and written by LLO for volunteer tutors and literacy instructors. This year we had over 1,600 visits to our LLO Publications page—a 29% increase from last year.

All proceeds from the <u>Laubach Literacy Bookstore</u> -- LLO's social enterprise -- are dedicated to supporting our member agencies and their adult literacy students, through subsidies to our Conference and substantial member discounts on New Readers Press materials.

As noted in the Treasurer's report, the bookstore had a pretty good year last year due to a large order submitted by the New Brunswick Public Library Service.

Due to the poor exchange U.S./Canada exchange rate we raised the prices in the bookstore by 10% in January of this year so we should see an improvement in profits this year.

Reading

Institute to Math &

The most ordered resource was Laubach Way to Reading, followed by Breakthrough to Math and Challenger. There was a 44% increase in the number of LWR views on our website over last year.

Offering customers the ability to pay by credit card has increased the non-member orders we receive. PayPal is more popular among non-members who used PayPal 57% of the time as opposed to members who only used PayPal 14% of the time.

Conference 2015: Lighting the Path to the Future

Laubach Literacy Ontario and Ontario Native Literacy Coalition partnered last year to provide an exciting, successful conference that was held at Lakehead University Orillia Campus from June 19-21, 2015.

This year there were 23 interesting and informative workshops that included a great selection for everyone.

There was also a sharing circle which gave Anglophone and Native LBS agencies an informal opportunity to share ideas, concerns, successes and challenges. And back by popular demand - a scavenger hunt for learners! All of this along with some great food and comfortable accommodations made for a busy but fun weekend.

We'd also like to thank co-hosts Orillia and District Literacy Council and The Literacy Society of South Muskoka for all of their help. Your help made our lives a lot easier and was very much appreciated.
